



2017 Summer School Program for kindergarten children



The "Summer School" service is dedicated to children attending the kindergarten. The Summer School purpose is to support parents that are working in the summer period but that, at the same time, want to provide the child with a play environment, permeated by creativity, different from the typically school-like one, being free from curriculum planning.

The Summer School project is therefore focused on the child perception of a holiday climate, through ludic-creative, manipulative, and sports experiences, organized and coordinated by the kindergarten teachers by implementing a right balance between fun activities, animation, team games, through a common and creative main theme.

The typology of this service is linked to the conviction that, during the summer period, children can develop socialization and creative skills, and can be educated to altruism by having fun with mates, in indoor and outdoor environments at school.

It is indispensable, to acquire an educational value, that these activities are not lived by the child as an occasional experience. It should become a continuous adventure of which the child will be the active protagonist, giving free rein to his/her imagination but also being able to learn how to finalize energies in achieving a precise goal. This gives full pedagogical value to such a short-lived activity.

The methodology adopted is based on the child's direct experience by following a common main theme to which the whole activity will be inspired, such as "bans" (group dancing), water games, treasure hunt, and much more.

Organization

The children's entrance and exit will take place on the school ground floor and in the school playground. The structure can accommodate about 40 children divided into two groups. Both groups provide a playful approach to painting, music, and manipulating activities inherent to the summer school main theme.

NECESSARY INFO

Required accessories:

A bag containing: at least 2 complete sets of dry clothes, a sun cap, sunscreen cream, a swimsuit, a beach towel, a pair of beach slippers

A Bib, a small towel, and a plastic glass

Important:

- On Mondays morning: place the towel and the plastic glass in the toilet in the towel holder
- And place the bib in the dining room in its "House"
- On Thursdays, the child must wear the swimsuit under the clothes
- It is forbidden to carry personal games and items
- Do not to give children any money
- In case of a not foreseen early exit, please telephone first.
- In case you need your child be taken by persons different from parents, or direct responsible, you will need to compile the delegation module (like the one at the end of the registration module) with a copy of their valid IDs. In any case, please, telephone first.
- In case of food allergies, you must notify them at the registration
- We remind you to have a look at the notice-board inside the school every day for any kind of communication
- In case of absence, please inform the school by a telephone call.

Object: INFORMATION ACCORDING TO ARTICLE 13, D.Lgs 19612003

Dear Sirs, we wish to inform you that law 196103 provides for the protection of persons and other subjects regarding the processing of personal data.

According to this law, this protection will be built on the principles of fairness and transparency and protection of your privacy and your rights.

Among the personal data you are asked for the completion of your application, we need to ask for so-defined "sensitive" data and in particular information concerning the health of the child. The presence of this information leads us to apply strict and binding rules of conduct to which all staff are required to follow.

In accordance with article 13, we wish to inform you as follows:

1. The information you provide concerning the pupil who will attend our school or his/her family, collected by direct questionnaire completed with the cooperation of our staff, will be processed solely for the evaluation of the application and the formation of the inclusion list and, where appropriate , the waiting list;
2. The provision of certain data is required (personal details of the child, the one who has parental responsibility, residence) pain of exclusion from the service. The other information is optional but we trust in your full cooperation in order to enable us to operate safely for the protection of the peace and health of your children and others. Furthermore, the failure to provide certain information may not allow the correct assessment of income components required for the development of the economic parameters;
3. In case the application is accepted, some data, together with other data that could require in the future, will be used to carry out the necessary administrative procedures;
4. The data will not be disclosed to other parties, nor will it be released without your prior written consent;
5. if registration will be confirmed, in the context of preparation of the Schedule of the child, you will be asked for more information and data and, at the same time, you will be provided a new information concerning the processes necessary for the frequency of our activities;
6. it is expected that you express your consent as a result of the information that we provided. We remind you that the denial of such consent will not allow us to provide the required services;
7. Data controller is the legal representative of the school Marangoni Don Antonio.
8. Manager of the treatments is the President Teresina Barausse and the teacher Zocchetta Marianna, you can talk with to them to exercise your rights under Article 7 recognised by the law, access, update.
